Youth Librarians President: Nicole Westbom Organizes 2015, NEASC issued a revised draft: <a href="https://cihe.neasc.org/standards-policies/november-2015-draft-standard">https://cihe.neasc.org/standards-policies/november-2015-draft-standard</a>. Although the new revised standards do not go as far as we would like in highlighting the importance of librarians and the library's role in an academic institution, the new revisions have added the word "librarians" (section 6.2) and added "services, facilities and qualified staff" to section 7.24: "the institution provides access to library and information resources, services, facilities, and qualified staff sufficient to support its teaching and learning environments and its research and public service mission as appropriate."

In other news, we are pleased to announce that Alana Verminski has stepped forward as nominee for vice president of CSL. Alana is the collection development librarian at Bailey/Howe Library at the University of Vermont.

Earlier this month, I had the pleasure of attending my first American Library Association Midwinter conference. While I was only there for the last two days of the four-day event, I had an incredible experience: meeting vendors, attending programs, and having the chance to listen to dynamic speakers including Cory Booker and Chelsea Clinton (Chelsea and I even got to have a little one-on-one chat about the ways we inspire kids to do great things! YAHOO!)

Being a first-time attendee was a bit overwhelming, as there is so much to do in so little time. And for a first-timer, the program booklet was difficult at best, so I was very glad I had spent the previous several days researching all the program offerings and making a schedule for myself. But I still found that I was missing sessions that were of interest to me, simply because I didn't know they existed. We shared ideas we had learned in earlier sessions, helped each other find our way around, and motivated each other to try some new things when we returned home. I even met someone who has experience with a technology project I'm trying to implement at my library, who is willing to actually come to my library and help make my vision a reality!

As a librarian, I feel it is so important to attend events like this to explore new topics, to meet people who understand what you do, and can relate and share opinions and expertise, to reinspire yourself (especially if you've been doing this a long time - it's easy to get comfortable and set in your ways and lose the passion you felt when you started your career). I can think of no better way to start the new year than being surrounded by innovative speakers, motivated colleagues, and fresh ideas!

#### Are You Our Next Webmaster?

We are seeking a new primary webmaster to join the VLA Membership and Outreach Team. This work is currently being performed by the committee chair, who will be cycling off the board in the next few months. There is also a secondary person who mainly works on back-end projects, serves as your back-up, and has worked on the board for a number of years and can help you navigate. You and your second will want to work out division of labor and all that once you get the lay of the land.

The most regular responsibility is timely maintenance of the Job Board and Events, which includes correspondence with folks seeking to list jobs or events, posting them on the website and

Facebook (which auto-posts to Twitter), and removing expired postings so we are current. There may also be appropriate jobs and events that you come across on listservs, Facebook, etc. so we'd love someone who is or is willing to be plugged into those outlets. Additionally, the webmaster works with other members of the VLA board to keep their sections of the website up-to-date, keep the main page looking fresh with current initiatives, build the Vermont Library Conference page as information becomes available, and keep our social media presence current.

Webmaster is not a huge time commitment most of the year, but can occasionally require more attention as the conference approaches, or if a big project is being undertaken by other members of the board. The most important qualities we're looking for in a webmaster is someone who regularly checks email and responds quickly, someone who is good at maintaining consistency and isn't afraid to ask questions, and someone who has a solid knowledge of basic HTML. VLA uses the Google family of products for collaborative work and organizational emails and the website is in Wordpress with a customized theme, so any knowledge of those platforms is a huge plus. There is a lot of room for you to build a team, because many hands make light work, and be creative in how you manage the website and social media.

The **Sarah C. Hagar Award** is awarded each year for outstanding service in or significant contribution to the field of librarianship in Vermont. Nominees for the Sarah C. Hagar award must be working in a Vermont library (public, academic, school, or special) and be a member of VLA.

The **Trustee of the Year Award** recognizes outstanding achievement by a trustee on behalf of his or her library, either during the previous year or during his or her years of service. Nominations may be submitted by any library trustee, library board, librarian, member of a friends group, or VLA member.

The Library Advocate of the Year Award is given occasionally by the VLA Government Relations Committee to an outstanding public advocate for libraries in local, state, or national government.

The **Green Mountain Award** is given as the opportunity arises to individuals or organizations for distinguished service, support, or unusual contributions to a Vermont library or libraries.

I began my three-year term as VLA's councilor to the American Library Association at the ALA Midwinter Meeting in Boston last month. It was great to see several Vermonters at the conference!

### **ALA Council highlights**

ALA Council is the governing body of the association, and much of the action and debate during council meetings consist of resolutions brought by council members for a vote. Resolutions passed during the 2016 Midwinter Council meetings include

- ·A resolution with recommendations for improved accessibility at ALA conferences
- ·A resolution condemning Islamophobia
- ·A resolution for restoring civil liberties and opposing mass surveillance that reaffirms ALA's commitment to intellectual freedom and urges the president and Congress to take steps to curb government surveillance

- ·A resolution to urge the Library of Congress to replace the subject heading "illegal aliens" with "undocumented immigrants"
- ·A resolution supporting ALA's Advocacy Implementation Plan, and encouraging divisions, chapters, and individual libraries to adopt the plan
- · A resolution to recognize the service of James Billington, former Librarian of Congress

#### Other Midwinter Highlights - Advocacy

Advocacy remains a strong focus for ALA, and there were many Midwinter sessions highlighting the Libraries Transform campaign (<a href="http://www.ala.org/transforminglibraries">http://www.ala.org/transforminglibraries</a>). This is a public awareness campaign and there are a lot of ways for libraries to get involved. The Aspen Institute also presented their brand-new action guide for public libraries, based on their recent report "Rising to the Challenge: Re-Envisioning Public Libraries."
